RELEASE OF SECURITY INTEREST IN PATENT RIGHTS

This RELEASE OF SECURITY INTEREST IN PATENT RIGHTS ("Release"), effective as of this 23rd day of June, 2016, given by JPMORGAN CHASE BANK, N.A., a national banking association, with an address at 10 S. Dearborn, 7th Floor, Chicago, IL 60603, as Administrative Agent ("Agent") to Orbotech Limited, an Israeli limited company ("Grantor"), as follows:

WHEREAS, pursuant to that certain Credit Agreement dated as of August 7, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders (as defined in the Credit Agreement) have agreed to extend credit to the Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Grantor executed that certain Pledge Agreement, dated as of February 25, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") and granted to the Agent a security interest in the United States patents and patent applications set forth on Schedule A attached hereto (the "Patents") to secure the Obligations (as defined in the Collateral Agreement);

WHEREAS, in furtherance of the Collateral Agreement, the Grantor executed a Patent Security Agreement, dated March 7, 2016 (the "Patent Security Agreement"), which was duly recorded on March 7, 2016, at Reel 038023 / Frame 0925 in the United States Patent and Trademark Office;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Patents to the Grantor and to terminate the encumbrance created by the Patent Security Agreement and the Collateral Agreement in respect of the Patents.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Patents created by the Patent Security Agreement and the Collateral Agreement and reassigns all right, title and interest it has in the Patents to the Grantor.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTOR'S AND THE ADMINISTRATIVE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
