11. Petitioner's change of name is in the interest or to the benefit of Petitioner and is in the interest of the public.

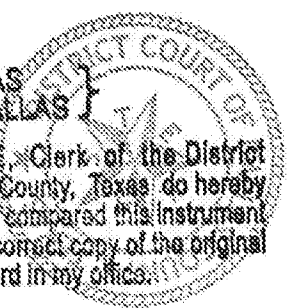
IT IS ORDERED that Petitioner's name is changed from Kevin Saied Afghani to Kevin Kinslow Thibodeaux.
