RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "**Release**") is made this 1st day of July, 2016 by Escalate Capital Partners SBIC I, L.P. (together with its successors and assigns, "**Lender**").

WHEREAS, reference is made to that certain Intellectual Property Security Agreement, dated as of January 6, 2014 (the "**Intellectual Property Security Agreement**"), by and between ControlScan, Inc., a Delaware corporation ("**Borrower**"), and Lender, which was recorded with the United States Patent and Trademark Office on January 22, 2014 (i) in the patent assignment records under reel/frame number 032112/0138, and (ii) in the trademark assignment records under reel/frame number 5198/0044; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Intellectual Property Security Agreement; and

WHEREAS, pursuant to the Intellectual Property Security Agreement, Borrower granted Lender a security interest in all of the right, title and interest of Borrower in and to the Intellectual Property Collateral identified therein.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases and terminates its security interest in and to the Intellectual Property Collateral arising under the Intellectual Property Security Agreement including, without limitation, the intellectual property described in Schedules A, B, and C hereto. Further, Lender understands and agrees that this Release may be recorded by or for Borrower with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Lender also agrees to execute any other

documents and take any further action reasonably necessary in any jurisdiction that Borrower may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of California without regard to conflicts of law principles.


