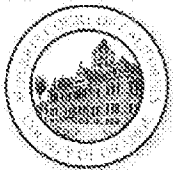

Dissolution or legal separation may automatically cancel the rights of a spouse or domestic partner under the other spouse's or domestic partner's will, trust, retirement plan, power of attorney, pay-on-death bank account, transfer-on-death vehicle registration, survivorship rights to any property owned in joint tenancy, and any other similar property interest. STATISTICAL FACTS

The Court finds as follows:

1. Petitioner and Respondent were married on June 29, 1988;
2. Petitioner and Respondent were separated on November 25, 2014;
3. Period between marriage and separation is 26 years and 5 months.
4. There are no minor children of this marriage.

The parties intend, by this stipulated judgment, to make a final and complete settlement of all of their rights and obligations concerning the issue of spousal support and division of property as follows:

CONFIRMATION OF SEPARATE PROPERTY ASSETS & DEBTS

7. The parties agree that their separate property and financial obligations are minimal, and that they have already divided said property and financial obligations to their mutual satisfaction. The parties each agree that whatever property is in the possession and control of that party is confirmed the sole and separate property of that party.

DIVISION OF COMMUNITY PROPERTY ASSETS

8. The parties warrant and declare under penalty of perjury that the assets and liabilities divided in this stipulated judgment constitutes all their community and quasi-community assets and liabilities. In the event that the division is unequal, the parties knowingly and intelligently waive an equal division of the community property.

9. Petitioner is awarded one hundred (100%) of the following assets as her share of the community property and she shall pay any encumbrances thereon and appear on behalf of, defend and hold Respondent harmless therefrom:
