**DEFAULT JUDGMENT AND SANCTIONS ENTRY**

This cause came to be heard upon plaintiff's Motion for Sanctions Including Default Judgment. A review of the record before this Court reveals that case has been ongoing for two and half years. During those two and half years, defendant Andrew C. Edge ("Edge"), has hired and fired at least two attorneys of record. The remaining defendants, Parabellum Innovations Corporation ("PIC"), Parabellum Armament Co. LLC ("PAC"), and Parabellum Armament Group LLC ("PAG") (collectively "Company Defendants") have fired their previous attorney of record and currently the Company Defendants are without representation in this matter. The Company Defendants have failed to appear in Court or participate in this case since June 2015. Both Edge and Company Defendants have repeatedly filed frivolous motions before this Court and their former attorney was subject to sanctions as a result of such motions. Both Edge and the Company Defendants have failed to attend depositions and Court dates throughout this case. The Court finds that Edge's and Company Defendants' conduct is sanctionable, including both monetary and non-monetary sanctions.

IT THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

1. Default Judgment shall be rendered against Edge and Company Defendants;
2. That all counterclaims brought by the Edge and the Company Defendants are hereby dismissed with prejudice;
3. The Court finds that plaintiff, Christopher F. Mitro ("Mitro"), is the rightful holder of all rights, title, and interest in and to Patent No. D654,135 and D654,134 ("Patents") and directs that this Order be filed with the United States Patent and Trademark Office Assignment Branch as evidence that Mitro is the rightful assignee of said Patents;
4. That Edge and the Company Defendants shall be permanently enjoined from making, using, or selling products that are covered by the Patents, including AKARS;
5. That Plaintiff shall be awarded attorney's fees in the amount of Six Hundred Dollars (\$600) for attendance at the mediation hearing of June 20, 2016 that was unattended by Edge and Company Defendants;
6. That Plaintiff shall be awarded attorney fees in the amount of Eleven Thousand Seven Hundred Dollars (\$11,700), plus costs of this action;


