RECITALS

- A. The Assignor is the applicant named in the application(s) for patent listed in the Schedule (**Patent applications**).
- B. The Assignor has agreed to assign all its right, title and interest in and to the Application to the Assignee on the terms set out in this Deed.

DEFINITIONS AND INTERPRETATION

Definitions:

"**Patents**" means all patents issuing on the Application or a Corresponding Application.

Interpretation:

In this Deed, unless the context otherwise requires:

- (a) a reference to legislation is to be taken as a reference to that legislation as amended, re-enacted or replaced and includes any subordinate legislation promulgated under it;
- (b) the singular includes the plural and vice versa;
- (c) where an expression is defined, another part of speech or grammatical form of that expression has a corresponding meaning.

Headings:

In this Deed, headings are for convenience of reference only and do not affect interpretation.

NOW THIS DEED WITNESSES as follows:

1. EFFECT OF DEED

Each party acknowledges that this Deed is effective on and from the abovementioned date.

2. ASSIGNMENT

For good and valuable consideration (receipt of which is hereby acknowledged by the Assignor), the Assignor hereby assigns to the Assignee absolutely all its right, title and interest in and to the:

- (a) the Application including, without limitation, the right to be named as applicant in the Application and all Corresponding Applications;
- (b) the Invention;
- (c) the right to claim priority from the Application; and
- (d) the right to sue for infringement of any Patents occurring prior to the date of Deed;

with the intention that all Patents, extensions, reissues and re-examinations of, and patents of addition to, Patents shall issue in the name of the Assignee absolutely.

3. GENERAL

3.1 Further Assurances

Each of the parties undertakes to execute all further documents and render all assistance reasonably required for the purpose of giving full effect to this Deed in any part of the world. Furthermore, the Assignor hereby appoints the Assignee to be its lawful attorney for

the purpose of executing or dealing with any document which is required to cause any of the Applications to be assigned to the Assignee with the intention that this power will continue to operate and have full force and effect after the Assignor ceases to have the power to do so to the extent lawfully permitted.

3.2 Variations

No variation of this Deed will be of any force or effect unless it is in writing and signed by each party to this Deed.

3.3 Governing Law

This Deed shall be governed by and construed according to the laws of the State of Victoria, Australia.

3.4 Counterparts

The Deed may be executed in counterparts by each party to this Deed, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same document. Each party shall be bound by this Deed immediately upon executing it.

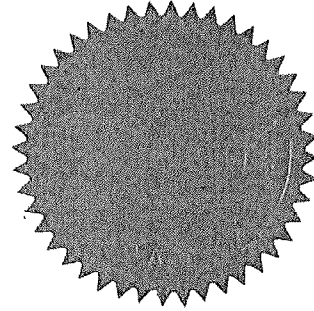
