THEREFORE, as an additional capital contribution to Assignee, in consideration of Assignor's equity interest in Assignee, Assignor assigns to Assignee, Assignee's successors, legal representatives, and assigns, the entire right, title, and interest in and to the Invention.

Assignor hereby warrants that Assignor will communicate to the Assignee, its successors, legal representatives, and assigns, any facts known to the Assignor respecting the Inventions, testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing, and reissue applications, make all rightful oaths, and generally do everything possible to aid Assignee, its successors, legal representatives, and assigns, to obtain and enforce protection for the Invention in all countries.

Assignor authorizes and requests the Commissioner for Patents of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of intellectual property protection on applications for such protection, to issue the same to Assignee, its successors, legal representatives, and assigns, in accordance with the terms of this agreement.
