INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), executed as of September 10, 2014 by and between Richard A. West ("Inventor") and West Development Group, LLC., a limited liability company organized under the laws of Ohio ("Assignee").

WHEREAS, Inventor is an inventor of certain intellectual property (defined below) including the patents and patent applications listed on Annex A hereto; and

Inventor hereby does transfer, assign and deliver unto Assignee, and Assignee hereby assumes and accepts, all of Inventor's worldwide rights, title, and interest in and to any and all intellectual and industrial property rights and other similar proprietary rights that (a) relate to Assignee's past or present actual business, or anticipated business, (b) result from any work done at any time for Assignee, (c) were made or conceived using the facilities, equipment or other property, whether tangible or intangible, of Assignee, or (d) were made or conceived in the course of employment or other service, in any jurisdiction throughout the world, whether registered or existing at common law, including without limitation all such rights pertaining to or deriving from trademarks, copyrights, trade secrets, software, and patents, including the patents and patent applications listed on Annex A hereto, together with all registrations and applications for the foregoing; all provisional, parent, continuation, continuation-in-part, continued prosecution, and divisional applications of the foregoing; all patents of addition of the foregoing; all continued examination, extensions, re-examinations, post-grant confirmations, supplemental perfection certificates amendments or reissues of the foregoing; all patents or patent applications that claim priority to or from the foregoing; all inventions claimed by any of the foregoing, all rights to claim priority to the foregoing including without limitation the right to be granted a patent in Paris Convention countries; all rights to request, apply for, file and register the foregoing; all rights of action arising from the foregoing, including without limitation all claims for damages by reason of present, past and future infringement or violation of the foregoing and all present, past and future rights to sue and collect damages or seek injunctive relief for any such infringement; and all income, royalties and any other payments now and hereafter due and/or payable to Inventor in respect of the foregoing, in each case, to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held by Inventor had this assignment not been made (collectively, the "Assigned Intellectual Property").

2. Inventor promptly shall, execute such documents, and do and perform such acts and things as Assignee may reasonably request to give effect to assure title to said Assigned Intellectual Property, document and record, perfect and enforce the assignment herein recited, including without limitation executing such other documents as may be required to give full

effect to and to perfect the rights of Assignee under this Assignment in and to the Assigned Intellectual Property worldwide and, upon request and at the expense of Assignee, will execute any additional or divisional applications for patents, and for the reissue of any Assigned Intellectual Property to be granted therefor, and will make any rightful oaths and do all lawful acts requisite for procuring the same or for aiding therein.

3. Inventor hereby authorizes and requests an official of the United States Patent and Trademark Office, and any official of any country foreign to the United States and of any intergovernmental organization, whose duty is to issue patent registrations or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

4. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Assignment and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware applicable to agreements made and to be performed entirely within the State of Delaware, without regard to the conflicts of laws principles thereof. This Assignment may be executed in the original or by facsimile in any number of counterparts, each of which shall be deemed to be an original and all of which together shall constitute one and the same instrument.
