
Assignors to Assignee the right to sue for any and all patent infringement occurring prior to the date of this Assignment.

Assignors hereby request that said Patents be issued in accordance with this Assignment.


Assignors further covenant and agree that, at the time of the execution and delivery of these presents, Assignors possess the unencumbered right and authority to make this Assignment.
