"Inferential Analysis Using Feedback for Extracting and Combining Cyber Risk Information"

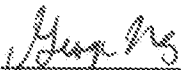

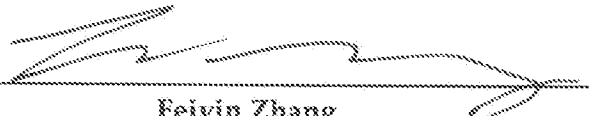

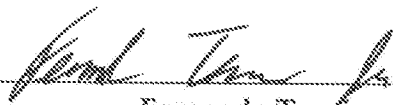
