

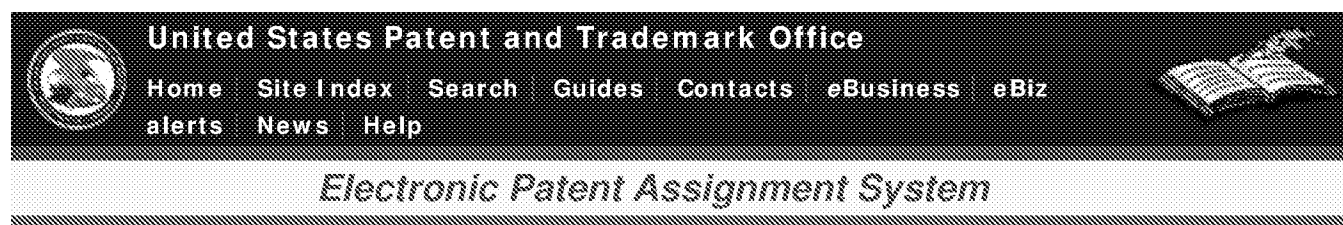

ASSIGNMENT OF PATENTS

This ASSIGNMENT OF PATENTS ("Assignment"), dated as of April 5, 2016, is entered into by THE PRIVATEBANK AND TRUST COMPANY, an Illinois state chartered bank ("Lender"), with an address of 120 South LaSalle Street, Chicago, IL 60603, and REFLECTION WINDOW COMPANY, LLC, an Illinois limited liability company ("Assignee") with an address of 2525 N Elston Ave., Chicago IL 60647.

RECITALS:

WHEREAS, Elston Window & Wall, LLC ("Owner"), an Illinois limited liability company with an address of 2525 N. Elston Ave., Chicago, IL 60647, was the owner of those certain patents and patent applications listed on Schedule A attached hereto and made a part hereof (the "Patents");

WHEREAS, Owner was indebted to Lender pursuant to that certain Loan and Security Agreement dated June 19, 2013, as amended (the "Loan Agreement");

WHEREAS, the Loan Agreement was secured by certain collateral, including the Patents;

WHEREAS, Owner defaulted upon its obligations to Lender under the Loan Agreement;

WHEREAS, Lender exercised its post-default remedies with respect to the collateral, including the Patents;

WHEREAS, Lender held a sale pursuant to 9-610 of the Illinois Uniform Commercial Code (the "UCC Sale");

WHEREAS, at the UCC Sale, Assignee purchased all of Owner's right, title and interest in, to and under the Patents;

WHEREAS, Assignee's purchase of the Patents is reflected in that certain Purchase Agreement dated April 1, 2016 (the "Purchase Agreement") and that certain Bill of Sale dated April 5, 2016 ("Bill of Sale") by and between Lender and Assignee, pursuant to which Lender sells, transfers, conveys, assigns and delivers to Assignee, and Assignee acquires, all of Owner's right, title and interest in, to and under the Patents.

NOW, THEREFORE, for good and valuable consideration provided in connection with the sale and purchase of assets pursuant to the Purchase Agreement and Bill of Sale, the receipt and sufficiency of which are hereby acknowledged, Lender hereby sells, assigns, transfers and conveys to Assignee, its successors and assigns, the Owner's entire right, title and interest in and to the Acquired Assets constituting the Patents, along with the Acquired Assets constituting (a) all rights to sue or recover and retain damages, costs and attorneys' fees for past, present and future infringement, misappropriation or other violation thereof; (b) all United States and foreign

patents and utility models and applications therefor, including all priority rights provided by any and all treaties, conventions, or agreements; (c) all reissues, divisions, re-examinations, revisions, renewals, extensions, provisionals, continuations and continuations-in-part thereof; and (d) equivalent or similar rights anywhere in the world in inventions and discoveries, including invention disclosures, disclosed or claimed therein (all of the foregoing assets identified in this paragraph are collectively the "Patent Acquired Assets").

ASSIGNEE ACKNOWLEDGES AND AGREES THAT EXCEPT WITH RESPECT TO, AND ONLY TO THE EXTENT OF, THE REPRESENTATIONS AND WARRANTIES SET FORTH IN ARTICLE 5 OF THE PURCHASE AGREEMENT MADE AS OF THE DATE OF THE PURCHASE AGREEMENT AND AS OF THE "CLOSING DATE" (AS DEFINED IN THE PURCHASE AGREEMENT): (A) THE SALE OF THE PATENT ACQUIRED ASSETS TO ASSIGNEE IS: WITHOUT RECOURSE TO LENDER; ON AN "AS IS, WHERE IS" BASIS; AND WITHOUT ANY REPRESENTATIONS OR WARRANTIES AS TO ITEMS, EXISTENCE, OWNERSHIP, TITLE, CONDITION, QUANTITY OR ANY OTHER MATTERS WHATSOEVER; (B) LENDER MAKES NO REPRESENTATION OR WARRANTY AS TO THE VALUE, IF ANY, OF THE PATENT ACQUIRED ASSETS BEING TRANSFERRED HEREBY; (C) LENDER MAKES NO REPRESENTATION OR WARRANTY CONCERNING THE POSSIBLE INFRINGEMENT OF ANY COPYRIGHTS, TRADEMARKS, TRADE NAMES PATENTS OR OTHER INTELLECTUAL PROPERTY ARISING OUT OF THE USE BY ASSIGNEE OF ANY OF THE PATENT ACQUIRED ASSETS; AND (D) LENDER MAKES NO REPRESENTATIONS OR WARRANTIES THAT ALL OR ANY PORTION OF THE PATENT ACQUIRED ASSETS ARE MERCHANTABLE (IN THE SENSE OF AN IMPLIED WARRANTY OF MERCHANTABILITY UNDER THE UCC OR OTHERWISE) OR FIT FOR A PARTICULAR PURPOSE.

Lender agrees to take, at Assignee's expense, such further action, execute such additional documents, provide testimony, and, in general, provide all lawful cooperation reasonably requested by Assignee to perfect Assignee's title in, to and under the Patents and to carry out and fulfill the purposes and intent of this Assignment of Patents.

The rights and obligations of Lender and Assignee shall be governed by, and this Assignment shall be interpreted, construed and enforced in accordance with, the laws of the State of Illinois, excluding its conflict of laws rules to the extent such rules would apply the law of another jurisdiction.

This Assignment may be signed in any number of counterparts, including facsimile copies thereof or electronic scan copies thereof delivered by electronic mail, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.

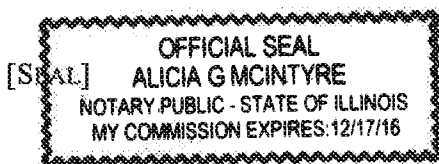
