The Assignor authorizes and empowers said Assignee, its successors, assigns and legal representatives or nominees, to invoke and to claim for any application for

patent or other form of protection for said invention or for additions and modifications thereto, filed by it or them, the benefit of the right of priority provided by: the International Convention for the Protection of Industrial Property, as amended; any convention which may henceforth be substituted for it; membership in the World Trade Organization; or any other applicable International treaty, convention or agreement; and to invoke and to claim such right of priority without further written or oral authorization from me.

The Assignor shall without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and to maintain applications and patents for said invention and for additions and modifications thereto in any and all countries, and to vest title thereto in said Assignee, its successors, assigns and legal representatives or nominees.

The Assignor authorizes and empowers the firm of Bereskin & Parr LLP/S.E.N.C.R.L., s.r.l., whose complete address is Suite 4000, 40 King Street West, Toronto, Ontario, Canada M5H 3Y2, the power to insert on this assignment any further identification, to prepare any translation which may be necessary or desirable in order to comply with the rules for recordation of this document in any country, and to correct any clerical error in this assignment.

In this assignment, in accordance with provisions of Article 2 (i) and (ii) PCT, "application" means an application for the protection of an invention; references to an "application" shall be construed as references to applications for patents for inventions, inventors' certificates, utility certificates, utility models, patents or certificates of addition, inventors' certificates of addition, and utility certificates of addition; references to a "patent" shall be construed as references to patents for inventions, inventors' certificates, utility certificates, utility models, patents or certificates of addition, inventors' certificates of addition, and utility certificates of addition.
