RELEASE OF PATENT SECURITY AGREEMENT

THIS RELEASE OF PATENT SECURITY AGREEMENT (this “Release”) is made as of May 4, 2016 (the “Effective Date”), by Credit Suisse AG, Cayman Islands Branch, as collateral agent (in such capacity, the “Agent”), in favor of McGraw-Hill Global Education Holdings, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Patent Security Agreement (defined below) including any defined terms incorporated by reference therein from the Collateral Agreement as provided in Section 1 of the Patent Security Agreement.

WHEREAS, pursuant to the terms and conditions of that certain Patent Security Agreement among each Grantor and the Agent dated as of March 22, 2013 (the “Patent Security Agreement”), the Grantor pledged and granted to the Agent a lien on and security interest in all of its right, title and interest in and to certain Patents of the United States of America;

WHEREAS, the Patent Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on March 25, 2013, at Reel 030081 and Frame 0367;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Patent Security Agreement, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the following IP Collateral:


All Patents of the United States of America, including those listed on Schedule 1 (the “Patent Collateral”).

If and to the extent the Agent has acquired any right, title or interest in or to any of the Patent Collateral, it hereby irrevocably re-assigns and re-transfers all such right, title and interest to the Grantor.

The Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, and at the Grantor’s cost and expense, to more fully and effectively effectuate the purposes of this Release.


