PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT (the "Assignment"), effective as of March 25, 2016 (the "Effective Date"), is entered into by and between Tyco Electronics UK Ltd, a company incorporated under the laws of England and Wales with registered number 00550926 having an address at Faraday Road, Dorcan, Swindon, SN3 5HH ("Assignor") and Littelfuse, Inc., a corporation organised and existing under the laws of Delaware ("Assignee"). Capitalized terms used but not defined herein shall have the meaning set forth in the Purchase Agreement (defined below).

RECITALS

WHEREAS, TE Connectivity Ltd., a Swiss Corporation (the "Seller") and Littelfuse, Inc., a Delaware corporation (the "Purchaser") have entered into a Stock and Asset Purchase Agreement dated as of November 7, 2015 (the "Purchase Agreement");

WHEREAS, Assignor owns the patents set forth on Schedule 1 hereto ("Assigned Patents") and, pursuant to the Purchase Agreement, desires to assign, convey, transfer, deliver and vest all of its right, title and interests in and to the Assigned Patents for all jurisdictions throughout the world, including all countries and political entities, to and in Assignee; and

WHEREAS, Assignee desires to accept from Assignor the Assigned Patents.

NOW, THEREFORE, for good and valuable consideration provided for in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby irrevocably assigns, conveys, transfers and delivers to Assignee, and Assignee hereby accepts, all of Assignor's entire, worldwide (for all jurisdictions throughout the world, including all countries and political entities) right, title and interest in and to the Assigned Patents, together with all corresponding counterpart patents and patent applications thereof, including, but not limited to, all continuation, divisional, continuation-in-part, continued prosecution applications, utility models, and provisional applications, any patents or reissued or re-examined patents resulting from any of the foregoing in any jurisdiction and any extensions thereof, as well as the right to invoke and claim priority thereto for all jurisdictions (in each case, limited to the Assignor's entire, worldwide right, title and interest therein), together with all income, royalties or payments due, accrued, or payable as of the Effective Date or thereafter, including, without limitation, any and all claims or causes of action for profits and damages by reason of past infringement of the Assigned Patents.

2. Assignor hereby consents that a copy of this Assignment shall be deemed a full and formal equivalent of any assignment, consent to file, or like document, which may be required in any country or region for recordation purposes for any of the foregoing rights conveyed herein.

3. In the event of a conflict between this Assignment and the Purchase Agreement,

said Purchase Agreement shall control. Nothing in this Assignment should be deemed to amend or modify in any way any of the terms and conditions of said Purchase Agreement or any rights or obligations of the parties thereto.

4. This Assignment shall be governed by and construed in accordance with the Laws of the State of Delaware, without regard to the conflicts of law principles of such state.

5. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. This Assignment may be executed in one or more counterparts and delivered via facsimile, pdf, or other electronic means, each of which shall be deemed an original as against the party that signed it and all of which shall together constitute one and the same agreement, and shall become effective when one or more counterparts have been signed by each of the Parties and delivered to the other Party, it being understood that all Parties need not sign the same counterpart.


