The Assignors represent and warrant that they have not granted and will not grant to any other any rights inconsistent with the rights granted herein.

The Assignors authorize and request the Director or Commissioner of Patents and Trademarks, as the case may be, of the United States, Canada and of all foreign countries to issue any design patent, industrial design, design right, utility model, petty patent, or utility patent granted for the Design, whether on said applications or on any subsequently filed division, continuation, continuation-in-part, or reissue application, to the Assignee, its successors and assigns, as the assignee of the entire interest in the Design.




