RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of June 30, 2016, is made by **WELLS FARGO ENERGY CAPITAL, INC., having an office at 1445 Ross Avenue, Suite 4500, Dallas, Texas 75202** ("**Administrative Agent**"), for each of the Secured Parties (as defined in the Credit Agreement referred to below), in favor of the Grantor (defined below). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Credit Agreement and the IP Security Agreement (defined below).

WHEREAS, reference is made to that certain Second Lien Credit Agreement dated as of November 17, 2014 (as amended, the "**Credit Agreement**"), among **J-W OPERATING COMPANY**, a Texas corporation, as a Borrower and as Borrower Representative, each of the other Borrowers from time to time party thereto, **J-W ENERGY COMPANY**, a Texas corporation, as Parent Guarantor, the Lenders party thereto, Administrative Agent, and the other Agents party thereto;

WHEREAS, as a condition precedent to the Secured Parties making their respective extensions of credit and other accommodations as set forth in the Loan Documents, Administrative Agent and **J-W OPERATING COMPANY**, a Texas corporation ("**Grantor**"), entered in to that certain Second Lien Intellectual Property Security Agreement (the "**IP Security Agreement**") dated as of November 17, 2014, recorded on November 18, 2014, in the United States Patent and Trademark Office against (i) various patents, commencing at Reel No. 034199, Frame No. 0735 and (ii) various trademarks, commencing at Reel No. 5403, Frame No. 0523, whereby Grantor granted to Administrative Agent a security interest in and to all patents and licenses of patents, trademarks, all registrations thereof and applications (other than "intent to use" applications until a verified statement of use or allegation of use is filed and accepted by the U.S. Patent and Trademark Office with respect to such applications) in connection therewith, whether registered or unregistered (the "**Intellectual Property**") of Grantor, as identified and/or described in the IP Security Agreement;


WHEREAS, in accordance with the terms of that certain Payoff Letter (the "**Pay-Off Letter**") dated of even date herewith and executed by Administrative Agent, the obligations secured by the Intellectual Property have been repaid or otherwise satisfied to the extent set forth in such Pay-Off Letter; and

WHEREAS, Administrative Agent now desires to release its security interests granted in the IP Security Agreement in the Intellectual Property identified and/or described in **Annex A** attached hereto (the "**Released Intellectual Property**").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby reassigns to Grantor all of its right, title and interest in and to the Released Intellectual Property and to the extent that the IP Security Agreement created a security interest in such Released Intellectual Property, Administrative Agent hereby releases such security interest.
