**DECLARATION REGARDING ERRONEOUS RECORDED  
TRANSFER OF OWNERSHIP OF PATENTS**

1. I, Raymond C. Sherry, have a residence and mailing address of 4221 St. Leger Drive, Cleburne, Texas 76033.

2. I am making this Declaration to correct an erroneous recordation of new ownership by another party, and restore ownership of my patents ("Patents") identified below and as indicated in the assignment records of the U.S. Patent and Trademark Office.

3. I am the listed inventor and current owner of the U.S. patents identified below:

- a) 7,963,459 – Self-cleaning High Pressure Nozzle
- b) 8,915,453 – Expansion Nozzle with Continuous Rotating Stem
- c) 8,602,320 – Expansion Nozzle with Motor Drive
- d) 8,097,128 – Method and Apparatus for Purifying Water
- e) 8,372,248 – Method and Apparatus for Purifying Water

4. The erroneous assignees of my above-identified patents currently of record in the assignment records are, "Aegis Production Services" and "Aegis Production Services, Inc." These two assignees were founded by James Hamilton, who is listed as correspondent in the erroneous assignment records. James Hamilton passed away on December 13, 2015 in Houston, Texas, according to the obituary published in the *Houston Chronicle* on February 14, 2016.

5. Assignments of the Patents identified in paragraph 3 above were recorded with the Assignment Services Division of the U.S. Patent and Trademark Office according to the following, it being noted that the first patent appears twice in the assignment records:

a) 7,963,459 – reel/frame 36678-755, on Feb. 27, 2012 to Aegis Production Services.

b) 7,963,459 – reel/frame 35657/523, on May 16, 2015, to Aegis Production Services, Inc.

c) 8,915,453 – reel/frame 36679-195, on Feb. 27, 2012 to Aegis Production Services Inc.

d) 8,602,320 – reel/frame 36679-102, on Feb. 27, 2012 to Aegis Production Services Inc.

e) 8,097,128 – reel/frame 36678-981, on Feb. 27, 2012 to Aegis Production Services Inc.

f) 8,372,248 – reel/frame 35658-525, on Feb. 27, 2012 to Aegis Production Services.

6. The true chain of title of each of the above-referenced patents still resides in the inventor, Raymond C. Sherry, as such patents were never assigned by the inventor. Raymond C. Sherry continues to be the true owner of the Patents, and any paper filed with the Assignment Records Division is not effective to change the original ownership of the Patents.

7. The previous and the current ownership of the Patents is as shown on the face sheets of the Patents as issued by the U.S. Patent and Trademark Office. The true chain of title of the Patents is that such Patents are currently owned by Raymond C. Sherry, and such true chain of title should not be considered as altered by the papers filed by either James Hamilton or the assignees identified in the erroneously-filed papers.

8. The erroneously-filed papers by either James Hamilton, or the assignees, are believed to be a purported Asset Purchase Agreement signed by various parties, including Raymond C. Sherry, and James Hamilton on behalf of Aegis Production Services, Inc. (“Aegis”), on February 27, 2012. Although this Agreement indicates that Raymond C. Sherry agrees to assign various patents to Aegis Production Services, Inc., the Agreement was breached by Aegis and a patent assignment document was never signed by Raymond C. Sherry to convey the Patents to another party.

9. Submitted herewith is a Patent Assignment Cover Sheet to correct the erroneous assignment papers filed by either James Hamilton or Aegis.

10. I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.
