
may obtain or recover as a result of the assertion or enforcement of any such claim or demand;

AND Assignors acknowledge an obligation of assignment of this invention to Assignee at the time the invention was made.



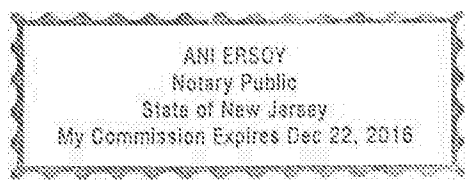
