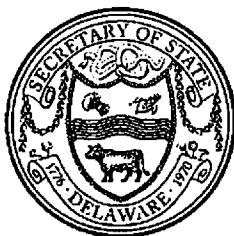



**SIXTH:** A copy of the Merger Agreement will be furnished by the Surviving Entity, on request and without cost, to any Member of the Merging Entity.


