Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

- FIRST:** The name of the surviving corporation is SDL Enterprise Technologies Inc., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is SDL Inc., a Utah corporation.
- SECOND:** The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8 Section 252 of the General Corporation Law of the State of Delaware.
- THIRD:** The name of the surviving corporation is SDL Enterprise Technologies Inc., a Delaware corporation, which will change its name to SDL Inc. immediately upon filing the Certificate of Merger.
- FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation. The Certificate of Incorporation shall be amended such that the name of the corporation shall be SDL Inc.
- FIFTH:** The authorized stock and par value of the non-Delaware corporation is 45,506,453 shares of Common Stock, no par value.
- SIXTH:** The merger is to become effective on December 30, 2015 at 1:00 PM EST.
- SEVENTH:** The Agreement of Merger is on file at 201 Edgewater Drive Wakefield, MA 01880, an office of the surviving corporation.
- EIGHTH:** A copy of the Agreement of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporations.
