PATENT ASSIGNMENT AGREEMENT



To the extent the Assignors of the Assigned Patents retained any right to sue for infringement of the Assigned Patents or to seek past or future damages for such infringement, the Assignors do grant such rights to Assignee.

Assignors hereby also sell, assign and transfer unto Assignee, the entire right, title and interest in and to the invention and in and to applications for Letters Patent therefore in all countries foreign to the United States of America, including all rights under any and all international conventions and treaties in respect of the invention and the applications for Letters Patent in foreign countries, and Assignors further authorize Assignee to apply for Letters Patent in foreign countries directly in its own name, and to claim priority of the filing date of the application for Letters Patent of the United States of America under the provisions of any and all international conventions and treaties.



Assignors hereby authorize and request the Commissioner of Patents of the United States of America to issue Letters Patent upon the aforesaid applications, divisions, extensions, continuations or reissues to Rothschild Patent Imaging, LLC for the sole use and benefit of Rothschild Patent Imaging, LLC, its successors, assigns and legal representatives, to the full end of the term for which the Letters Patent may be granted, the same as they would have been held and enjoyed by Assignors had this assignment not been made, and Assignors hereby authorize and request the equivalent authorities in foreign countries to issue the patents of their respective countries to Rothschild Patent Imaging, LLC.


