PATENT ASSIGNMENT

WHEREAS, WE, Viahaslau Urvantsau (a citizen of the Republic of Belarus) and Carenne Larcher (a citizen of France) (collectively "Assignors") are co-inventors of the invention entitled "System and Method for Auto Distilling Liquids at Strictly Defined Conditions Regardless of Composition" for which a non-provisional patent application, has been filed with the U.S. Patent and Trademark Office; and

WHEREAS, Instrumentation Scientifique de Laboratoire ISL (Assignee), located at Parc D'Activites De La Mesnilliere, Verson, France F-14790, is desirous of obtaining the entire rights, titles, and interests in, to, and under the same inventions identified herein above;

NOW, THEREFORE, in consideration of the sum of ten dollars (\$10.00) to the Assignors in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, we, the said Assignors, do hereby sell, assign, transfer, and set over unto the Assignee, its successors, legal representatives, and assigns, the entire right, title, and interest in, to, and under the said invention, and the United States application and all non-provisional applications, divisions, renewals and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for the invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from the United States application under the patent laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; all forms of industrial property protection, including, without limitation, patents, utility models, and design that may be granted for the invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and any and all causes of action thereto that may have heretofore accrued in Assignor's favor;



AND ASSIGNORS HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;

AND ASSIGNORS HEREBY further covenant and agree that we will communicate to the Assignee, its successors, legal representatives, and assigns, any facts known to it respecting the invention, and testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing

and reissue applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for the invention(s) in all countries including the right to sue for and recover for prior acts of infringement.


