WHEREAS, the **ASSIGNOR** wishes to execute this deed of assignment confirming the assignment of all their rights, title and interest under any and all patents which may be granted therefore, and under any and all extensions, divisional, reissues and continuation applications, for all countries, in the invention to the Assignee;

NOW THEREFORE, in consideration of the premises and of the mutual covenants and promises contained hereto, it is hereby agreed as follows:-

ARTICLE 1 - DEFINITIONS

1.1 Unless otherwise required by the context, the following terms as used in this Assignment shall have the respective meanings as defined below:

Patent Application No. PCT/US2011/050715 filed on 07th September 2011, claiming priority from United Kingdom Patent Application No. 1014820.3 filed on 7th September 2010, also from United States of America Patent Application No. 61/433,774 filed on 18th January 2011, also from United Kingdom Patent Application No. 1115339.2 filed on 6th September 2011 and from International Patent Application No. PCT/GB2011/051659 filed on 6th September 2011.

ARTICLE 2 – ASSIGNMENT

- 2.1 In consideration of a sum of US \$ 1/ (US Dollar ONE only) paid to the Assignor by the Assignee, the receipt of which is acknowledged hereunder by the Assignor, the Assignor does hereby sell, assign and transfer unto the Assignee, its successors and assigns, their entire right, title and interest, for all countries, in and to the Invention the same to be held and enjoyed by the Assignee absolutely.
