ASSIGNMENT

WHEREAS, we, John W. Jinnings, Brian Widenhoefer and James J. Connerley, residing at 9301 Garman Road, Leo, Indiana 46765, 16324 Fleetwood Court, Hometown, Indiana 46748 and 7084 English Oak Drive, Noblesville, Indiana 46062, respectively, have invented certain improvements in:

RECIPROCATING HAMMER WITH DOWNWARD THRUST ASSIST

as described and claimed in a U.S. Provisional Application No. 62/073,297, filed October 31, 2014 and in an International Patent Application thereon, said application having Application Serial No. PCT/US2015/012468, filed January 22, 2015; and

Connerley, do hereby assign, sell, transfer and set over unto said Hercules Machinery Corporation, its successors and assigns, the full, entire and exclusive right, title and interest, for the territory of the United States of America and for all foreign countries, in and to said invention, as described in the application identified above, and in and to said application and any divisions or continuations or continuations-in-part thereof or substitutes therefor which may be filed, and in and to any patents or reissues, renewals or extensions thereof which may be granted on said application or for said invention, and in and to any patent application which may be filed on said invention in countries foreign to the United States of America and any patents granted thereon; said invention, applications, and patents to be held and enjoyed by said Hercules Machinery Corporation, and its successors or assigns, to the full end of the term or terms for which said patents may be granted, as fully and entirely as the same would have been held by us had this assignment not been made.

We hereby authorize and request the Patent and Trademark Office officials in the United States of America and the Patent Office officials of any and all foreign countries to issue any and all of said patents, when granted to said Hercules Machinery Corporation, as the assignee of our entire right, title and interest in and to the same for the sole use and enjoyment of said Hercules Machinery Corporation, its successors and assigns.
