**AND**, we hereby authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or jurisdiction foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said invention to said FMC CORPORATION, as sole assignee.

This Power of Attorney includes, but is not limited to, applying for, securing, maintaining, reissuing, extending, or defending ASSIGNEE's worldwide rights in the invention in any country worldwide, so as to secure to ASSIGNEE the full benefits of the invention and otherwise to carry into full force and effect the text and the intent of this Assignment. This grant of authority is a special power of attorney coupled with an interest, is irrevocable and shall survive the incapacity of Assignor, may be exercised by any representative of ASSIGNEE on behalf of ASSIGNOR by a facsimile or electronic signature, and shall survive the termination of this Agreement or any other relationship between ASSIGNOR and ASSIGNEE.

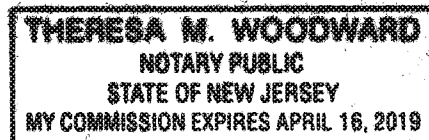
