ASSIGNMENT

WHEREAS, Raimon CASTELLS DE MONET, Jose Antonio ALVAREZ TAPIA and David CLARAMUNT MORERA are inventors of an invention subject to Patent Cooperation Treaty PCT Application No. PCT/US2011/021159 filed 13 January 2011 and entitled "SPINDLE"


