ANNULAR OZONE CONVERTER WITH REPLACEABLE CORE

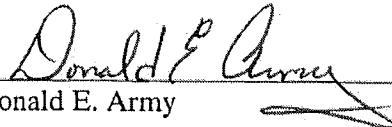
which is set forth in an application in the United States executed on even date herewith:
