AUTHORIZE the ASSIGNEE to apply for and receive any and all patents or their legal equivalents in any jurisdiction relating to any of the Improvements in its own name;

AUTHORIZE AND REQUEST the issuing authority to issue any and all patents or their legal equivalents granted in any jurisdiction for any of the Improvements to and in the name of the ASSIGNEE;


WARRANT AND COVENANT that no assignment, grant, security interest, license or other agreement or encumbrance affecting the rights and property herein conveyed, or ASSIGNEE's rights to the rights and property herein conveyed has been or will be made or entered into by the undersigned, and that ASSIGNOR possesses the full right to convey the same as herein expressed and to provide ASSIGNEE with all right, title and interest in and to the Intellectual Property Rights, including, but not limited to, the Improvements and the Related Applications;

ASSIGNEE all documents and things known and accessible to the undersigned relating to any of the Improvements and the histories thereof, and testify as to the same in any interference, derivation proceedings, litigation or other proceeding relating to the Improvements, the histories thereof, the '760 Provisional Application and the '764 Application or any of the other Intellectual Property Rights; and generally to do everything possible which the ASSIGNEE shall consider desirable for vesting title to such Improvements, the '760 Provisional Application and the '764 Application and all of the other Intellectual Property Rights in the ASSIGNEE, and to secure, maintain, defend and enforce valid and enforceable patent protection for the Improvements, the '760 Provisional Application and the '764 Application and all of the other Intellectual Property Rights;
