ASSIGNMENT



ALSO, the Inventor hereby authorizes and requests the Commissioner for Patents of the United States and any official of any country or countries foreign to the United States whose duty it is to issue Letters Patent or similar legal rights, to issue all such Letters Patent or similar rights for the Inventions to the Assignee, as assignee of the entire right, title, and interest in and to the Inventions, for the Assignee's own use and benefit, and for the use and benefit of the Assignee's successors, assigns and legal representatives, to the full end of the term for which such Letters Patent or similar rights may be granted, as fully and entirely as the same would have been held and enjoyed by the Inventors had this assignment not been made.

ALSO, the Inventors hereby covenant and agree to execute and deliver to Assignee, its successors, assigns or legal representatives any documents that legally may be necessary or desirable in connection with the filing, prosecution and maintenance of the Application or any other application for patent which has been or shall be filed in the United States and its territorial possessions or in any foreign countries for the Inventions, including any additional documents or instruments of transfer to affirm the rights of Assignee, its successors, assigns or legal representatives in and to the Inventions, all without further consideration. Each inventor also agrees, without requesting or receiving additional consideration from Assignee, but at Assignee's expense, to identify and communicate to Assignee, its successors, assigns or legal representatives all facts known to the Inventor relating to the Inventions and the history of the Inventions, and to provide further assurances and testimony on behalf of Assignee, its successors, assigns or legal representatives that lawfully may be necessary or desirable with respect to the prosecution, maintenance, enforcement, or defense of any patent application or Letters Patent encompassed within the terms of this assignment. Each Inventor's obligations under this assignment shall extend to the Inventor's heirs, executors, administrators, and legal representatives.


