## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "**Release**"), dated as of August 10, 2016 is made by BBH CAPITAL PARTNERS III, L.P., a Delaware limited partnership located at 140 Broadway, New York, NY 10005 (the "**BBH Fund**", together with its successors and assigns, "**Assignor**"), in favor of REVEAL IMAGING TECHNOLOGIES, INC., a Delaware corporation located at 55 Middlesex Tpk. Bedford, MA 01730-1421 ("**Assignee**").

### WITNESSETH:

**WHEREAS**, Assignee and Assignor are parties to (i) that certain Guaranty and Collateral Agreement, dated as of February 13, 2008 (the "**Guarantee and Collateral Agreement**") and (ii) that certain Intellectual Property Security Agreement and Collateral Assignment, dated as of February 13, 2008 (the "**IP Security Agreement**");

**WHEREAS**, pursuant to the IP Security Agreement, to secure the payment and performance of the Obligations, Assignee confirmed and acknowledged that it had granted, assigned and conveyed (and, to the extent not previously granted under the Guarantee and Collateral Agreement, it thereby granted, assigned and conveyed) to Assignor, a security interest in Assignee's entire right, title and interest in Assignee's Intellectual Property and all proprietary rights relating to or arising from such Intellectual Property, in each case whether then owned or thereafter acquired by Assignee, and including, without limitation, Assignee's right, title and interest in and to each Intellectual Property and proprietary rights identified on Schedule 1 attached hereto and made a part hereof, and the right to sue for past, present and future infringements and dilutions, and all rights corresponding thereto throughout the world, and the entire goodwill of Assignee's business connected with and symbolized by the Intellectual Property and all income, fees, royalties, proceeds and other payments at any time due or payable with respect to any of the foregoing (referred to collectively as the "**IP Collateral**").

**WHEREAS**, the IP Security Agreement was recorded with the United States Patent and Trademark Office on February 19, 2008 at Reel/Frame No. 020518/0751 and Reel/Frame No. 003721/0332;

**WHEREAS**, Assignee desires that Assignor terminate, release and discharge fully its security interest in all right, title and interest in the IP Collateral.

**NOW THEREFORE**, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor agrees as follows:

**SECTION 1. Defined Terms.** Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the IP Security Agreement.

**SECTION 2. Termination and Release.** Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its security interest in all right, title and interest in the IP Collateral, including the Intellectual Property listed on Schedule I attached hereto, and reassigns and transfers to Assignees all right, title and interest that Assignor may have in the IP Collateral. Assignor acknowledges and agrees that the IP Security Agreement and Assignee's obligations thereunder have been (and to the extent not already terminated, is hereby) terminated and of no further force or effect.

**SECTION 3. Recordation.** Assignor hereby authorizes Assignee, or Assignee's authorized representative, to record this Release with the United States Patent and Trademark Office.


**SECTION 4. Further Assurances.** Assignor hereby agrees to duly execute and deliver to Assignee any further documents and to do such other acts that Assignee (or its respective agents or designees) reasonably request, at Assignee's sole cost and expense, in order to confirm this Release and Assignee's right, title and interest in the IP Collateral.

**SECTION 5. Governing Law.** THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO ITS CHOICE OF LAW PROVISIONS.
