Assignor makes no representations, extends no warranties or indemnification of any kind, expressed or implied, nor assumes any responsibilities whatsoever with respect to the manufacture, use, sale or other disposition by Assignees or its successors of products incorporating or made by use of inventions as may be claimed in the Patent.

Nothing in this agreement shall constitute or be construed as a warranty or representation by Assignor to the commercial utility of any Patent or product made under any Patent.

Nothing in this Agreement shall constitute or be construed as a warranty or representation by Assignor that the manufacture, use or sale of any product does not infringe any patent or any other intellectual property right owned by any third party.


