PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT (this "Assignment"), dated as of July 5, 2016, is made by Staples Contract & Commercial, Inc., a Delaware corporation ("Assignor"), to Taylor Communications, Inc., a Minnesota corporation ("Assignee"), a subsidiary of Taylor Corporation ("Buyer").

Assignor and Buyer, among others, are parties to an Asset Purchase Agreement, dated as of April 15, 2016 (as amended to date, the "Agreement"); and

Buyer has assigned all rights and obligations under the Agreement to Assignee; and

2. Assignor agrees to execute all assignments and other papers necessary to fully secure to Assignee the right, title and interest conveyed herein, at Assignee's expense and upon Assignee's reasonable request.
3. Assignor and Assignee agree that this Assignment is subject to all the terms and conditions of the Agreement and shall be governed by the governing law and venue provisions of the Agreement. This Assignment is intended to effect the sale, assignment, transfer and conveyance of the Patents to Assignee as described in the Agreement and nothing contained in this Assignment shall in any way modify, supersede, rescind, waive, exceed, expand, enlarge or in any other way affect the terms (including the representations and warranties or the rights, remedies or obligations of any party) of the Agreement. In the event of a conflict or controversy between the terms of this Assignment and the terms of the Agreement, the terms of the Agreement shall control. This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument. This Assignment, along with the Agreement and its Exhibits, constitutes the entire understanding and agreement of the parties hereto with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the parties with respect hereto. This Assignment may not be altered or modified in any manner except by a writing signed by the parties hereto.
