RELEASE OF SECURITY INTEREST IN PATENTS

(Patents, Patent Applications and Patent Licenses)

THIS RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”) is made as of August 19, 2016 (“Effective Date”) by U.S. Bank Trustees Limited, as collateral agent (in such capacity, together with its successors and assigns in such capacity (“Collateral Agent”), in favor of Markport Limited, a company incorporated in the Republic of Ireland (herein referred to as the “Grantor”). All terms not herein defined, have the meanings set forth in the Credit Agreement, the Debenture of the Intellectual Property Security Agreement referenced below (collectively, the “Agreements”).

WHEREAS, Acision B.V. a *besloten vennootschap met beperkte aansprakelijkheid* incorporated in the Netherlands, having its statutory seat in Nieuwegein and registered with the Dutch trade register under number 34266530 (the “Parent”), certain subsidiaries of Parent party thereto as Borrowers, certain lenders, Elavon Financial Services Limited, as administrative agent and U.S. Bank Trustees Limited, as Collateral Agent are, among others, parties to a Credit Agreement, dated as of December 15, 2014 (as amended, supplemented, restated or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, Grantor is wholly owned direct or indirect Subsidiary of Parent;

WHEREAS, pursuant to a Debenture, dated as of December 15, 2014 (as amended, supplemented, restated or otherwise modified from time to time, (the “Debenture”), entered into between, among others, the Grantor and U.S. Bank Limited, as Collateral Agent (including its successors, permitted assigns and transferees), the Grantor secured the Secured Obligations (as defined in the Debenture) by granting to the Collateral Agent as security trustee for the Secured Parties (as defined in the Debenture) a continuing security interest in personal property of the Grantor, including all right, title and interest of the Grantor in, to and under the Intellectual Property Collateral;

WHEREAS, pursuant to the Debenture, the Grantor was required to execute and deliver an Intellectual Property Security Agreement, dated as of December 15, 2014 (the “Intellectual Property Security Agreement”) which the Grantor granted to the Collateral Agent for the benefit of the Secured Parties, to the extent provided in the Debenture, a security interest in all of its right, title and interest in, to and under all the patents, whether now owned or at any time hereafter acquired, of such Grantor that are registered with, or for which applications for registration have been filed with the United States Patent and Trademark Office (“USPTO”), including the patents listed on the attached Schedule 1, and all registrations and pending applications associated therewith (collectively, the “Intellectual Property Collateral”);

WHEREAS, the Intellectual Property Security Agreement was recorded in the USPTO on December 19, 2014 at Reel/Frame 034557/0343; and

WHEREAS, the Collateral Agent, on behalf of itself and the Secured Parties, has been requested to release its security interest in the Intellectual Property Collateral and any and all rights granted to the Collateral Agent under the Agreements.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of itself and the Secured Parties, hereby without representation, warranty or recourse) terminates, releases and discharges any security interest in and lien upon the Intellectual Property Collateral, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, to, or under the Intellectual Property Collateral that the Collateral Agent may hold.


