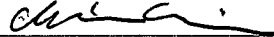
AND ASSIGNOR(s) acknowledge an obligation of assignment in this invention to ASSIGNEE at the time the invention was made;

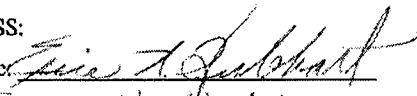
