## RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this "Release") is given as of this 1st day of August 2016, by Wells Fargo Bank, National Association, a national banking association; located at 190 River Road, Summit, New Jersey, 07901 ("Assignor"), in favor of TUMI, INC., a New Jersey corporation ("Assignee"), located at 1001 Durham Avenue, South Plainfield, New Jersey 07080. Assignee and Assignor are herein after referred to as the "Parties".

WHEREAS, Assignee, as borrower, certain subsidiaries of Assignee, as Guarantors, Assignor, as administrative agent, collateral agent, swing line lender and issuing lender, Capital One, N.A., as syndication agent, and Sovereign Bank and Citizens Bank of Pennsylvania, each as a documentation agent, and Wells Fargo Securities, LLC and Capital One, N.A. as Joint Lead Arrangers and Joint Bookrunners ("Assignor, Capital One, N.A., Sovereign Bank and Citizens Bank of Pennsylvania are hereinafter collectively referred to as the "Syndication Parties"), entered into that certain Credit and Guaranty Agreement (the "Original Agreement") dated as of October 29, 2010.

WHEREAS, in consideration of the extensions of credit and other accommodations of Assignor as set forth in the Original Agreement, respectively, Assignee agreed to secure its obligations to the Syndication Parties in part pursuant to that certain Pledge and Security Agreement (the "Original Pledge Agreement") dated as of October 29, 2010 and pursuant to that certain Patent Security Agreement (the "Patent Security Agreement") dated as of October 29, 2010.

WHEREAS, pursuant to the Patent Security Agreement, Assignee granted to Assignor a security interest and continuing lien on all of Assignee's right, title and interest in, to, and under (i) all United States patents and certificates of Invention, or similar industrial property rights, and applications for the foregoing in each case that are owned by Assignee, including, but not limited to: (a) each patent and patent application referred to in **SCHEDULE A** hereto (as such schedule may be amended or supplemented from time to time), (b) all reissues, divisions, continuations, continuations-in-part, extensions, and reexaminations thereof, (c) all rights to sue for past, present and future infringements; thereof, (d) all proceeds of the foregoing, including, without limitation, royalties, income, payments, damage awards and proceeds of suit (collectively the "Patents"); (ii) to the extent not otherwise included above, all Collateral Records, Collateral Support and Supporting Obligations relating to any of the foregoing; and (iii) to the extent not otherwise included above, all Proceeds, products, accessions, rents and profits of or in respect of any of the foregoing (collectively, the "Patent Collateral"); and

WHEREAS, the Original Agreement was amended and restated pursuant to that certain Amended and Restated Credit and Guaranty Agreement, dated as of April 4, 2012, by and among Assignee, as borrower, certain Subsidiaries of Assignee, as Guarantors, and Assignor, as Lender and Collateral Agent, (as it may be amended, supplemented, restated or otherwise modified, the "Credit Agreement") and the Original Pledge Agreement was amended and restated pursuant to that certain Amended and Restated Pledge and Security Agreement dated as of April 4, 2012 (the "Pledge Agreement") by and between Assignee and Assignor;

WHEREAS, in connection with the execution of the Credit Agreement all rights of the Syndicated Parties pursuant to the Patent Security Agreement, were assigned to Assignor; and

WHEREAS, the Parties desire that Assignor terminate and release its security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby terminates, releases and discharges fully, without representation, recourse or warranty whatsoever, all of its security interest in the Patent Collateral including, but not limited to, the Patents referred to on **SCHEDULE A** hereto, whether granted pursuant to the Security Agreement, Patent Security Agreement or any other agreement or document delivered in connection with the Credit Agreement or the Original Agreement, and Assignor hereby reassigns and transfers any and all right, title and interest that it may have in the Patent Collateral to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Patent Collateral including, without limitation, the patents, and (iii) otherwise file this Release.

Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments, and do any and all further acts which Assignee (or its agents or designees) reasonably requests in order to confirm this Release and to confirm Assignee's right, title, and interest in and to the Patent Collateral.

Capitalized terms used in this Release but not defined herein shall have the respective meanings ascribed to them in the Patent Security Agreement, Security Agreement or Credit Agreement, as applicable.

This Release and the rights and obligations of the Parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York, without regard to its conflicts of law provisions.


