**ASSIGNMENT**

WHEREAS, I, Duke Sangyoung Yoo, residing at 11 Robby Lane, East Haven, CT 06512, have invented certain new and useful improvements in Destruction of Target Cells Utilizing Harmonic Resonance Cavitation for which I:

have filed a provisional application for Letters Patent of the United States on March 14, 2013 under Serial No. US 61/785,321 and a non-provisional patent application on March 13, 2014 under Serial Number 14/209,159; and

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, I have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto Plumeria Holdings, LLC, its successors, legal representatives, and assigns the entire right, title, and interest in, to and under the improvements, and the application and all divisions, renewals, and continuations thereof, and all Letters Patents of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patents which may hereafter be filed for the improvements in any country or countries foreign to the United States, and all Letters Patents which may be granted for the improvements in any country or countries foreign to the United States and all extensions, renewals, and reissues thereof; and I hereby authorize and request the Commissioner of Patents of the United States and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvement to Plumeria Holdings, LLC, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.


AND I HEREBY further covenant and agree that I will communicate to Plumeria Holdings, LLC, its successors, legal representatives and assigns, any facts known to me respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid Plumeria Holdings, LLC its successors, legal representatives and assigns to obtain and enforce proper patent protection for the improvements in all countries.

AND I HEREBY further assign and transfer to Plumeria Holdings, LLC all priority rights derived from such application therefore by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International convention and I do hereby assign and transfer to Plumeria Holdings, LLC the sole right to file further applications for patents under the patent laws of any country of the world based on any improvements disclosed in said application as fully and entirely as the same would have been held by me had this assignment not been made.

I authorize the insertion of a filing date and serial number, when received, to identify the patent application that is the subject of this Assignment.
