which is set forth in an application in the United States executed on February 28, 2014, United States Serial Number 61/946,123.

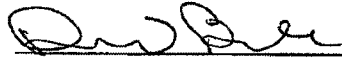

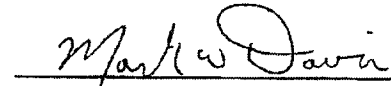
