UPON SAID CONSIDERATION, I hereby covenant and agree with ResMed R&D that I will not execute any writing or do any act whatsoever conflicting with these presents, and that I will, at any time upon request, without further or additional consideration, but at the expense of ResMed R&D, execute such additional assignments and other writings and do such additional acts as ResMed R&D may deem necessary or desirable to perfect ResMed R&D's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, renewal, reissued or extended Letters Patent of the United States or of any and all
