RECITALS

- A. The Assignor agrees with the Assignee to assign all of its rights, title and interest in, and to, the Intellectual Property to the Assignee on the terms set out in this Deed.

OPERATIVE PROVISIONS

1. INTERPRETATION

1.1 Definitions

The following definitions apply to this Deed.

Intellectual Property means the patent application(s) listed in Schedule 1 attached and any patent application(s) that claim priority from the patent application(s) listed in Schedule 1 and the invention(s) disclosed in the patent application(s) and any patent(s) that may be granted on the patent application(s) and the design application(s) and design registration(s) listed in Schedule 1.

Territory means the Commonwealth of Australia and all other countries and jurisdictions throughout the world.

2. ASSIGNMENT

In consideration of the sum of \$1.00 now paid by the Assignee to the Assignor, the receipt and sufficiency of which the Assignor acknowledges, the

Assignor assigns to the Assignee, absolutely, all of its rights, title and interest in, and to, the Intellectual Property throughout the Territory, including:

- (a) the right to make further patent applications and/or design applications relating to any of the inventions and/or designs; and
- (b) the right to absolute ownership of any patent(s) or design registration(s) granted on any of the patent application(s) or in respect of any of the invention(s) or any of the design application(s).

3. GENERAL

3.1 Amendment

This Deed can only be amended, supplemented, replaced or novated by another document signed by the parties.

3.2 Governing law

- (a) This Deed is governed by the law in force in New South Wales, Australia.
- (b) Each party submits to the non-exclusive jurisdiction of the courts exercising jurisdiction in New South Wales, Australia, and any court that may hear appeals from any of those courts, for any proceedings in connection with this document, and waives any right it might have to claim that those courts are an inconvenient forum.

3.3 Giving effect to this Deed

Each party must do anything (including execute any document), and must ensure that its employees and agents do anything (including execute any document), that the other party may reasonably require to give full effect to this Deed.

3.4 Operation of this Deed


- (a) This Deed contains the entire agreement between the parties about its subject matter. Any previous understanding, agreement, representation or warranty relating to that subject matter is replaced by this Deed and has no further effect.
- (b) Any right that a person may have under this Deed is in addition to, and does not replace or limit, any other right that the person may have.
- (c) Any provision of this Deed which is unenforceable or partly unenforceable is, where possible, to be severed to the extent necessary to make this document enforceable, unless this would materially change the intended effect of this document.

3.5 Counterparts


