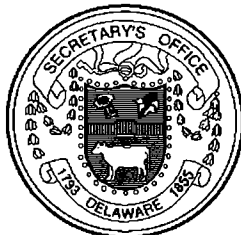

The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:
