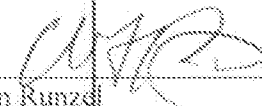
PATENT ASSIGNMENT

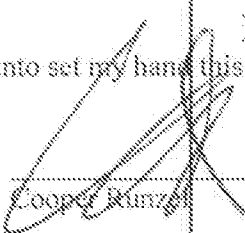

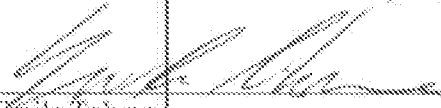

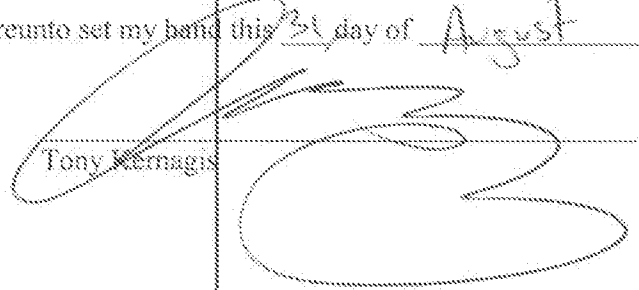
