## ASSIGNMENT

AUTHORIZE the ASSIGNEE to apply for and receive, in its own name, any and all patents or their legal equivalents in any jurisdiction relating to the Improvements;

AUTHORIZE AND REQUEST the issuing authority to issue any and all patents or their legal equivalents granted in any jurisdiction relating to any of the Improvements to and in the name of the ASSIGNEE;





the '882 Application, any Related Application and/or the history of any of the foregoing, and generally to do everything possible which the ASSIGNEE shall consider desirable for vesting title to all of the Intellectual Property Rights in the ASSIGNEE, and to secure, maintain, defend and enforce valid and enforceable patent protection for the Improvements;

AGREE AND ACKNOWLEDGE that the SALE, ASSIGNMENT AND TRANSFER of the Intellectual Property Rights, as set forth herein, is and shall be IRREVOCABLE and BINDING upon the heirs, assigns, representatives and successors of the ASSIGNOR and EXTEND to the successors, assigns and nominees of the ASSIGNEE.
