RELEASE OF SECURITY INTEREST IN PATENTS

This Release of Security Interest in Patents (“Patent Release”), effective as of this 15th day of August, 2016, is given by Citibank, N.A. (“Collateral Agent”) to Avon Products, Inc. (“Grantor”) as follows:

W I T N E S S E T H

WHEREAS, pursuant to that certain API Security Agreement, by and between the parties hereto, dated as of June 5, 2015 (the “Security Agreement”) and that certain Patent Security Agreement, by and between the parties hereto, dated as of June 5, 2015 (the “Patent Security Agreement”), Grantor granted to Collateral Agent a security interest in and to substantially all of Grantor’s personal property, whether then-existing or thereafter acquired, including without limitation:

- (a) All letters patent of, or rights corresponding thereto in, the United States or any other country, all registrations and recordings thereof, and all applications for letters patent of, or rights corresponding thereto, in the United States or any other country, including, without limitation, registrations, recordings and applications in the United States Patent and Trademark Office (“USPTO”) or in any similar office or agency of the United States, any State thereof or any other country; all reissues, continuations, continuations-in-part, divisionals or extensions thereof; and all patents to be issued under any such applications, including without limitation the patents and patent applications set forth on Schedule A attached hereto (collectively, the “Patents”);

- (b) Any and all claims for damages by way of past, present and future infringement of any of the Patents, with the right, but not the obligation, to use for and collect such damages for said use or infringement of the Patents;

(c) All licenses or other rights to use any of the Patents, and all license fees and royalties arising from such use to the extent permitted by such license or rights; and

(d) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing;

(collectively, the "Patent Collateral"); and

WHEREAS, pursuant to the Second Amendment to Credit Agreement and General Security Agreement and First Amendment to API Limited Recourse Guaranty, dated as of August 1, 2016, among the Grantor, the Collateral Agent and the other parties thereto, Collateral Agent wishes to release and restore all right, title and interest in and to the Patent Collateral to Grantor and to dissolve any and all liens and encumbrances respecting the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. Release. Collateral Agent hereby releases, discharges, quit claims and relinquishes unto Grantor the security interest in all Patents granted to Collateral Agent by Grantor pursuant to the Security Agreement and Patent Security Agreement, which security interest was duly recorded on June 12, 2015, at Reel 035899, Frame 0776 at the USPTO. Collateral Agent hereby assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Patent Collateral. Collateral Agent acknowledges and agrees that, as a result of this Patent Release, it has no further rights to or interest in the Patent Collateral.
2. Further Assurances. Collateral Agent hereby agrees, at Grantor's expense, to execute such instruments and to take such other actions as Grantor may reasonably request to terminate Collateral Agent's security interest in the Patent Collateral, and otherwise to effectuate the release of the Patent Collateral from Collateral Agent's security interest.

3. Recordation. Collateral Agent hereby authorizes and requests the governing body of the USPTO to record this termination and release of security interest in the Patent Collateral.
