For the same consideration, I hereby authorize the insertion of the filing date and serial number above.

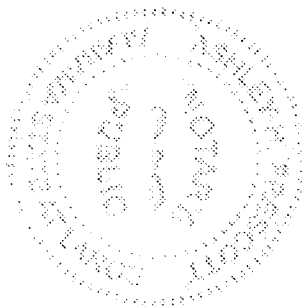
