CERTIFICATE OF MERGER

OF

ALFA LAVAL TANK EQUIPMENT INC., a Delaware corporation

AND

ALFA LAVAL INC., a New Jersey corporation

It is hereby certified that:

1. The constituent business corporations participating in the merger herein certified are:

(I) Alfa Laval Tank Equipment Inc., which is incorporated under the laws of the State of Delaware; and

(ii) Alfa Laval Inc., which is incorporated under the laws of the State of New Jersey.

2. An Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the aforesaid constituent corporations in accordance with the provisions of subsection (c) of Section 252 of the Delaware General Corporation Law, to wit, by Alfa Laval Tank Equipment Inc. in the same manner as is provided in Section 251 of the Delaware General Corporation Law and by Alfa Laval Inc., in accordance with the laws of the State of its incorporation.

3. The name of the surviving corporation in the merger herein certified is Alfa Laval Inc., a New Jersey corporation, which will continue its existence as said surviving corporation under its present name upon the effective date of said merger pursuant to the provisions of the laws of the State of its incorporation.

4. The certificate of incorporation of Alfa Laval Inc., as now in force and effect, shall continue to be the certificate of incorporation of said surviving corporation until amended and changed pursuant to the provisions of the laws of the State of its incorporation.

5. An executed copy of the Agreement of Merger between the aforesaid constituent corporations is on file at the principal place of business of the aforesaid surviving corporation, the address of which is as follows:

6. A copy of the aforesaid Agreement of Merger will be furnished by the aforesaid surviving corporation, on request, and without cost, to any shareholder of each of the aforesaid constituent corporations.

The aforesaid surviving corporation does hereby agree that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of Alfa Laval Tank Equipment Inc., as well as for enforcement of any obligation of said surviving corporation arising from the merger herein certified, including any suit or other proceeding to enforce the right, if any, of any shareholder of Alfa Laval Tank Equipment Inc. as determined in appraisal proceedings pursuant to the provisions of Section 262 of the Delaware General Corporation Law; does hereby irrevocably appoint the Secretary of State of the State of Delaware as its agent to accept service of process in any such suit or other proceedings; and does hereby specify the following as the address to which a copy of such process shall be mailed by the Secretary of State of the State of Delaware:

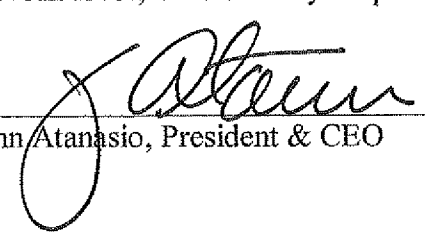
