ASSIGNMENT OF PATENTS

This Assignment Agreement ("Assignment Agreement") is made effective as of the Closing Date (the "Effective Date") by and between MIGHTY NET, INC., a California corporation (the "Assignor") and CONSUMERINFO.COM, a California corporation ("Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement dated September 7, 2010 ("Purchase Agreement"), pursuant to which Assignor sold, conveyed, assigned and transferred to Assignee, among other assets, the entire title, rights, interests, benefits, and privileges in and to all Patents owned or purported to be owned by Assignor, including but not limited to those specified on Exhibit A hereto (collectively, the "Assigned Patents"). Capitalized terms used but not defined in this Assignment Agreement shall have the respective meanings ascribed to such terms in the Purchase Agreement.

NOW, THEREFORE, for valuable consideration furnished by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby, without reservation:

A. Assigns, transfers, sells and conveys, and confirms that is has assigned, transferred, sold and conveyed to Assignee the whole entire right, title, and interest in and to the Assigned Patents, including all inventions and discoveries disclosed therein or encompassed thereby, all provisional and nonprovisional applications relating to the Assigned Patents or claiming the benefit thereof that have been or may hereafter be filed in the United States or in any foreign country and all divisionals, continuations, continuations-in-part, extensions, reexaminations and reissues relating thereto, and the right to sue for and the remedies resulting from past and future infringement of the foregoing, and rights of protection of interest therein under the Laws of all jurisdictions.

1. Authorizes Assignee to file patent applications in any or all countries for any or all of said inventions and discoveries in Assignor's name or in the name of Assignee or otherwise as Assignee may deem advisable, under any treaty, convention or otherwise.

2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all Assigned Patents to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.

3. Represents that it is the exclusive owner of the Assigned Patents with full authority to assign rights in the Assigned Patents, and further represents that Sheldon Kasower is the sole inventor of all Assigned Patents.

4. Covenants, agrees and undertakes to execute, whenever requested by the Assignee, all patent applications, assignments, lawful oaths and any other papers which Assignee may deem necessary or desirable for securing to Assignee or for maintaining for Assignee all the Assigned Patents, all without further compensation to the Assignor.

5. Agrees that Assignor is hereby legally bound, upon request and at the expense of Assignee or its successors or assigns or a legal representative thereof, to supply all information

and evidence of which the Assignor has knowledge or possession, relating to the making and practicing of the inventions and discoveries, and testify in any legal proceeding relating thereto.

6. Hereby constitutes and appoints Assignee as Assignor's true and lawful attorney in fact, with full power of substitution in Assignor's name and stead, but for Assignee's benefit, to take any and all steps, including proceedings at Law, in equity or otherwise to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest the aforesaid Assigned Patents and causes of action more effectively in Assignee or to protect the same, or to enforce any claim or right of any kind with respect thereto. This includes any rights with respect to the Patents that may have accrued in Assignor's favor up to the effective date of this Assignment Agreement. Assignor hereby declares that the foregoing power is coupled with an interest and is irrevocable.

This Assignment Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. This Assignment Agreement may not be amended except by an instrument in writing signed by each of the parties hereto.




