2. The Assignors hereby covenant and agree to cooperate with the Assignee to enable the Assignee to enjoy to the fullest extent the right, title and interest to the Invention herein conveyed in any and all countries and groups of countries. Such cooperation by the Assignors shall include prompt production of pertinent facts and documents, giving testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by the Assignee (a) for perfecting in the Assignee the right, title and interest herein conveyed; (b) for prosecuting the Applications; (c) for filing and prosecuting substitute, divisional, continuing or additional applications covering embodiments of the Invention; (d) for filing and prosecuting applications for reissuance of any of the Patents; (e) for interference or other priority proceedings involving the Invention; and (f) for legal proceedings involving the Invention and any application therefor and any Patents granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions.


3. The term and covenants of this agreement shall inure to the benefit of the Assignee, its successors, assigns and other legal representatives, and shall be binding upon the Assignors, their respective heirs, legal representatives and assigns.

4. The Assignors hereby warrant and represent that they have not entered and will not enter into any assignment, contract, or understanding in conflict herewith.

5. The Assignors further hereby authorize Assignee, or its attorneys or agents, to insert the correct Application Number and Filing Date into this Assignment, if none is indicated on the date of my execution of this agreement.
