Patents and Trademarks Assignment

This Assignment is made by and between Dalia (Dully) Katzeff Berman, Berthold Berman, and Sensocrete, Inc., having a principle office at 1223 de Lexington, St. Lazare, Quebec, CANADA ("ASSIGNORS"), and GCP Applied Technologies Inc., a Delaware Corporation ("ASSIGNEE"), having a principle office at 62 Whittemore Avenue, Cambridge, Massachusetts, 02140.

WHEREAS, pursuant to the Business Asset Purchase And Sale Agreement ("P&S Agreement") entered into between ASSIGNORS and ASSIGNEE of near or even date herewith, the ASSIGNORS transfer to ASSIGNEE all of ASSIGNORS' rights and title in and to patents and patent applications set forth in Appendix A, and rights and title in and to the global trademark set forth in Appendix B which the ASSIGNOR enjoy, together with the goodwill of the business with which the trademark set forth in Appendix B is used, to the extent that ASSIGNORS individually and/or collectively have rights and title in and to the patents, patent applications, and trademark (the items set forth in Appendix A and Appendix B collectively referred to herein as the "ASSIGNED IP"); and

WHEREAS, the ASSIGNEE hereby agrees to accept the rights and title in and to the patents and patent applications set forth in Appendix A and the rights and title in and to the trademark set forth in Appendix B, together with the goodwill of the business with which the global trademark set forth in Appendix B is used or that ASSIGNORS may enjoy to the extent ASSIGNORS have a right of title in said patents and/or patent application and in said trademark.

NOW, THEREFORE, in consideration of the foregoing and the promises, covenants and agreements contained herein and intending to be legally bound, ASSIGNEE and ASSIGNORS agree as follows.

In consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which ASSIGNORS acknowledge, ASSIGNORS have sold, assigned, transferred, and set over, and do, by this Assignment, sell, assign, transfer, and set over unto ASSIGNEE, its successors, assigns, and legal representatives, her/his/their entire right, title, and interest, including the right to compromise, sue and collect damages for past and future infringement, as well as to collect royalties and claim a right of priority with respect to the ASSIGNED IP (together with the goodwill of the business assets with which the global trademark includable as ASSIGNED IP is used), and, the same to be held and enjoyed by ASSIGNEE, its assigns, successors, and legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNORS had this assignment and transfer not been made.

ASSIGNORS hereby assign and transfers to ASSIGNEE her/his/their entire right, title, and interest in and to any and all counterparts relating to the ASSIGNED IP, including world-wide patents, patent applications, patent disclosures, including all re-examinations, reissues, divisions, continuations, continuations-in-part, substitutions, filings, registrations, or extensions of the ASSIGNED IP; and, if applicable, such right includes the right to compromise, to sue, and to collect damages for past and future infringement, as well to collect royalties and to claim right of priority with respect to the ASSIGNED IP; and such right shall be held and enjoyed by ASSIGNEE, its assigns, successors, and legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNORS had such assignment and transfer not been made.

ASSIGNEE shall be solely responsible for the maintenance of the ASSIGNED IP as of the effective date hereof and all expenses associated therewith, and may proceed in its sole discretion to maintain the ASSIGNED IP or dispose of it as it or its assigns, successors, and legal representatives see fit.

ASSIGNEE shall be solely responsible for recording ASSIGNEE's right, title, and interest in ASSIGNED IP, and all expenses associated therewith, and may proceed in its sole discretion to record the ASSIGNED IP in the name of ASSIGNEE or its designee.

This Assignment is subject to the terms and conditions of the P&S Agreement. Neither the representations and warranties, nor the rights and remedies of either party under the P&S Agreement shall be deemed to be enlarged, modified, or altered in any way by this Assignment.

All questions concerning the construction, validity and interpretation of this Assignment (and all appendices hereto) will be governed by and construed in accordance with the internal laws of New York, excluding any conflict-of-law provisions thereof that would otherwise require the application of the law of any other jurisdiction.

The effective date of this Agreement shall be August 9, 2016.

It is further understood that "Dalia (Dully) Katzeff Berman" is also known as "Dully Katzeff Berman," "Dully Katzeff-Berman" (with or without dash), and "Dully Katzeff"; and further understood that any of these alternative spellings as may be used on any of the patents, patent applications, or their counterparts, as listed in the attached Appendix A; and that these shall be understood to refer the same individual ASSIGNOR whose signature is subscribed hereunder.

IN WITNESS WHEREOF, ASSIGNORS and ASSIGNEE have each caused this Assignment to be signed in their own names (in the case of Individuals) and in their corporate name by their duly authorized officers (in the case of corporations).
