FAN BLADE WITH STRUCTURAL SPAR AND INTEGRATED LEADING EDGE

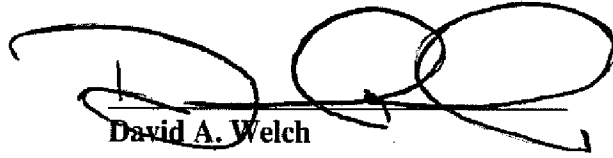
