## ASSIGNMENT OF PATENT RIGHTS

WHEREAS, ARCHER INNOVATIONS, LLC, a limited liability company organized and existing under and by virtue of the laws of the State of Georgia and having its principal office and place of business in Columbus, Muscogee County, Georgia (hereinafter referred to "Archer"), acquired the hereinafter described patent from ASHLEY R. HATCHER, a citizen of the United States of America, residing in Columbus, Muscogee County, Georgia (hereinafter sometimes referred to as "Hatcher"), who invented one or more of said inventions related to utility and design of certain "Lapper trays" (hereinafter referred to as the "Invention(s)") disclosed in the following United States patent (the "Hatcher Intellectual Property"): U.S. Patent No. 7,506,763, entitled ""Food tray with non-slip inserts" and issued on March 24, 2009;

WHEREAS, Hatcher is desirous of reacquiring all right, title and interest in and to the Invention(s) and the Hatcher Intellectual Property from Archer.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged by the undersigned, Archer has sold, assigned, transferred and set over, and does by these presents hereby sell, assign, transfer and set over unto Hatcher all its right, title and interest in and to the Invention(s) and the Hatcher Intellectual Property, including but not limited to the right to apply for any Letters Patent of the United States of America and in any and all foreign countries on the Invention(s), and any and all other applications for Letters Patent on the Invention(s), in whatsoever countries, including all divisional, renewal, substitute, continuation, continuation-in-part and convention applications based in whole or in part upon the Invention(s) or upon or related to the Hatcher Intellectual Property, and any and all Letters Patent which may issue thereon in the United States and foreign countries, and any and all reissues, extensions, renewals, divisions, continuations or continuations-in-part of Letters Patent granted for the Invention(s) or upon the Hatcher Intellectual Property, to the full term or terms for which said Letters Patent may be issued, and every priority right that is or may be predicated upon or arise from the Invention(s) and/or the Hatcher Intellectual Property, the same to be held and enjoyed by Hatcher for her own use and benefit fully and entirely as if the same would have been held and enjoyed by Archer had this Assignment not been made. Archer hereby authorizes Hatcher to file patent applications in any and all countries for any or all of the Invention(s) in Archer's name, or in her name, or otherwise as Hatcher may deem advisable, under the International Convention or otherwise.

Archer hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue patents, to record this Assignment, and to issue or transfer all Letters Patent on the Invention(s), including but not necessarily limited to the Hatcher Intellectual Property, to Hatcher as owner of all right, title and interest therein, or otherwise as Hatcher may direct, in accordance with the terms of this Assignment.






